<p>If Michigan CLASS directly or indirectly administers or maintains an official internet presence, any public records available to the general public on that internet site at the time the request is made are exempt from any labor charges to redact (<i>separate exempt information from non-exempt information</i>).</p> <p>If the FOIA coordinator knows or has reason to know that all or a portion of the requested information is available on its website, Michigan CLASS must notify the requestor in its written response that all or a portion of the requested information is available on its website. The written response, to the degree practicable in the specific instance, must include a specific webpage address where the requested information is available. An individual is ineligible for this fee reduction if <b>ANY</b> of the following apply:</p> <p style="margin-left: 20px;">(i) The individual has previously received discounted copies of public records from the same public body twice during that calendar year,  (ii) The individual requests the information in conjunction with outside parties who are offering or providing payment or other remuneration to the individual to make the request.
